Chair of the Advisory Council, Melissa Ward welcomed the appointment of four strong candidates who offered a broad range of skills and experience in local tourism, transport, environment, business, culture and heritage.

The first meeting of the Advisory Council is scheduled for 1 July 2015.

The Advisory Council is an interim body, established under the Norfolk Island Act 1979 to represent the Norfolk Island community until the Norfolk Island Regional Council commences on 1 July 2016.

Members of the Advisory Council will be appointed for a period of up to 12 months on a part-time basis.


We were not aware of who Mr. Burns was, his family connections, or his connection to the island.

Christmas And Norfolk Islands Governance Conference

An informal governance conference between the Shire of Christmas Island representatives and the Norfolk Island Government was held in the

Norfolk Island Legislative Assembly Chambers on 9 and 10 June 2015.

The theme of the conference was 'It is for the people to determine the destiny of its Territory and not the Territory the destiny of the people'.

The conference discussed;

- The historical backgrounds to both the Norfolk Island and Christmas Island and governance arrangements.
- The Joint standing Committee of the National Capital and External Territories inquiry into Norfolk Island and the current inquiry into the Governance of the Indian Ocean Territories
- Economic Development, Financial Implications and Self Governance
- The Meaning of Self Determination & United Nations Intervention

There was identified the need for greater dialogue between the External Territories of Norfolk Island and Christmas Island as we move into a changing political environment driven by the Commonwealth aimed at reducing and removing the democratic rights of the people in the External Territories.

To this extent there is a commitment between Norfolk Island and Christmas Island to work closely together in ensuring their communities are fully informed of the consequences of the reform agenda of the Commonwealth, and to where possible develop joint responses. This is to also include regular meetings between representatives of both External Territories.

A Happy Bounty Day to You All - continued

Today we celebrate, the traditions of language, food, farming and crafts; cultural practices reflected in laws, land and education; our culture of hospitality and help.

We proudly boast the substance of the first British place to secure compulsory education for our children. Additionally, the first to secure universal suffrage – all should have the vote, including women, revolutionary at that time. Governor Denison records when retaining the laws relating to enfranchisement of women, that he hoped his imperial masters would not accuse him of "petticoat government"!

These are not small, minor, nor token components of our lives, but factors which daily influence our comings and goings in this small but sceptered isle.

The prelude, to Norfolk Island's establishment as the next home of the Pitcairn Islanders, that is the Mutiny on the Bounty, the Tahiti existence, the Pitcairn hideaway, has been told in volumes by various authors: Thos. Boyles Murray; Lady Diana Belcher; The Nordoff & Hall editions; Rosalind Amelia Young's publications, all well read books of their time.

The pre-Norfolk Island prelude has been robustly recorded on film, in at least three versions of "Mutiny on the Bounty" with Bligh and Christian played by movie greats from the Clark Gable, Charles Laughton and Errol Flynn era to today's Anthony Hopkins and Mel Gibson.

These epics have had a natural eye on romance and royalties yet have nevertheless preserved and perpetuated the historical happening, and equally, knowledge of

the eventual creation of a new group of people in a far away place in the sun, with a living peculiar to their place.

Following that prelude, Norfolk Island's past in the sequence of the Pitcairn and Norfolk Island people is equally told in published works, from the respected Merval Hoare, to more recent authors exampled by Raymond Nobbs. Dozens of Norfolk Island books now are available to tell different parts of the Norfolk Island story.

It is still my dream that someone will record the full, authoritative and readable tale of the making of a Pitcairn and Norfolk Island people; from the despatch from England, to the shores of Tahiti through the Pacific seas, to isolated isles. To tell a tale of building a people from so little to remarkable achievements.

To have been at grave risk, from time to time, and yet, we have survived!

I can see the various volumes, each with companion volumes of original documents. The work would take years of research, consolidation and writing, but it cries out to be done. Someone may yet achieve it.

On film - This very day in this compound, we have Australian SBS filming a documentary for an hours viewing on television "Coming Soon" as they say in that world.

And, Channel 7 of Australian television has flown a crew to the Island to put on current news channels, the events of Anniversary (Bounty) Day in Norfolk Island.

Ours indeed is a story of unusual people and a unique place; both punching well above their weight.

The responsibilities of our era: Your responsibility; My responsibility; Our responsibility, is to maintain the impetus of knowledge about the Pitcairn and Norfolk Island people; their establishment, with imperial consent, of their home in Norfolk Island, for them, their descendants, forever.

Our culture, traditions and heritage of which I have already spoken;

Our responsibility, is to keep our history intact, the truth of its existence alive so that it is not consigned to the shelves of obscurity to become nothing but a dusty inconvenience.

And TODAY, is a major day to achieve that end and of immense significance that we turn out and do it together and as our people of 1856, sought, and were guided by their Lord in their comings and goings, we too, seek the same guidance, from the same Lord in our work and responsibilities of today.

HAPPY BOUNTY DAY TO YOU ALL.

We will sing grace "Be present at our table Lord", then feast and be merry at our picnic lunch together.

Each couple in each section were individually introduced as they took their places on the floor.







"The Democracy of Norfolk Island is being destroyed. It's astounding!"

This comment, during an interview last week, caused Louci Reynolds from VL2Ni to exclaim "I think we are almost speechless here."

The interview was conducted between Robin Adams, Minister for Cultural Heritage and Community Services and Radio announcer Louci Reynolds who spoke with Gordon Thompson, President of the Shire of Christmas Island and Kelvin Mathews, Chief Executive Officer.

Robin Adams explained that the visit really came about through the initiative of Kelvin Mathews, the CEO of Christmas Island and who is doing his PhD. and has been doing a comparative study between Norfolk Island and the Indian Ocean Territories (IOT) and how our two government models work.

"The decision was taken that we would have a conference between their government and our government" Robin continued "and we have done that over the last two days. It has been absolutely fabulous. The theme for the Conference is, and I will let Kelvin and Gordon talk more to the theme, but it is "For the People to Determine the Destiny of its Territory and not the Territory the Destiny of the People". So that was the theme around which the Conference agenda items were woven and we talked about the historical backgrounds to our two respective places, the flawed process of the Joint Standing Committee (JSC) in respect of Norfolk Island and of course Christmas Island at the moment has the JSC making enquiries into them, but I will let them talk more about that. We finished up with having a teleconference link up with Australia on the meaning of 'Self Determination' and the United Nations intervention which was a very well received hour long presentation with a constitutional Lawyer off shore.

Radio announcer then continued with the interview:

Louci - Gordon it's lovely to meet you. You were at the meeting yesterday. It was lovely to hear both of you speak. Can you give our listeners a basic run-down on how the 9 Member Shire works?

Gordon: Well the Shire Council is like Local Government throughout Australia. Shire Councils don't have any constitutional standing so they are constituted under various Acts so each State will have an Act called the Local Government Act and the control of local government on the mainland actually comes under the Minister for Local Government in each State or Territory.

We don't have a Minister in our Territory. We are a non-self governing Territory. So the laws that apply on Christmas Island are the applied laws of the Western Australia Parliament. We don't have any vote for any representative in that parliament. So our Conference over the last two days - Tuesday and Wednesday - with the Norfolk Island Government has been about the essential issue of democracy - "What is it and Why Does our Central Government want to take it away".

We hold great fears for ourselves, but we've been very, very shocked and disturbed as to what has happened on Norfolk Island and we wanted to come and meet with your government to see exactly how that happened; how could this come about; and what are the impacts likely to be?

Louci - Because the reciprocal information that you have, that you are currently in that we are transitionary to and also visa versa what the Norfolk Island Government can provide you with information must be huge.

Absolutely. In 1999 there was a delegation from the Shire of Christmas Island to Norfolk Island because we were looking at the governance issue. As I said, we are a non-self governing Territory, we are still a Colony.

Christmas Island was a British colony until 1958 when the United Kingdom Government acted to transfer the ownership of the Colony of Christmas Island from Britain to Australia. This was in an atmosphere of decolonisation throughout the world under the auspices of the United Nations. For some reason, Christmas Island was not listed as a non self-governing Territory with a U.N. mandated Territory requiring an act of self determination. Whereas our near neighbour, Cocos Keeling Islands, was inscribed on the list of non self-governing Territories and therefore entitled to an act of self determination.

Louci - and there is one of our major similarities.

Exactly. Norfolk Island was of great interest to us because you had a Legislative Assembly. So in 1999, our delegation were searching for how we achieve democracy in our Territory. The absence of democracy has been of great concern to our community ever since Australia took control of the Colony of Christmas Island.

So coming to Norfolk Island in 1999 was to look at your model and we were very impressed by that and we pursued argument in, and submissions to, the JSC in 2005/2006 and we were very, very interested in the application of the Norfolk Island model to Christmas Island. Now we've seen what happened with the JSC treatment, the government's treatment - all parties in fact of the Federal Parliament - have colluded to destroy your democracy and that's a great shock to us and we needed to come here, meet with you, understand how this could happen.

It seemed anti ethical of course to Liberal party and Labor party philosophy of government, and government is based on a democratic institution of voting for local representatives to make the laws that govern your lives. Now you're loosing it - we want it! We've never had it.

Louci - Yes, and you're right in the middle of this JSC investigation into governance of Christmas Island.

That's right, and we don't know what's coming. But we've had a hint. We can see what has happened here and what we see is a very old Colonial model. We see a complete reversal of what has happened on Norfolk Island before. But world-wide, when governments decolonise, when the Colonial powers decided to give self government to peoples of communities that had

been colonised by the great powers, we saw a process of 'advisory committees', 'advisory councils' advising the power, the central power as to what the wishes of the people are. So it is mighty strange for us to see your elected government of the people of Norfolk Island being replaced by an 'advisory council' and the installation of a virtual dictator in the form of your Administrator.

Robin Adams - and the return to colonialism.

Well, that's exactly right. It is a reversal. It's astounding and it's astounding that the Australian Parliament could go this way. I think the reason for that, and we only have to look at the numbers sitting in the Parliament when the Legislation was passed. I think there were 5 members of the House of Representatives in the House at the time the legislation was passed to destroy your democracy. In the Senate we don't know the numbers, but it was something similar.

We don't know how it could happen that so few members of a democracy, a democratically elected parliament could absent themselves at a time when the democracy of Norfolk Island is being destroyed. It's astounding!

Louci - I think we are almost speechless here. Kelvin have you got something to add to that.

Kelvin Mathews said "he summed it up very well. We were at the meeting last night and it touched all of our hearts, especially at the end with the singing of the Pitcairn Anthem. We have continued to shake our heads for 2 days and asked 'how did this happen?' and what have they done to you?

We are used to fighting. It's been the culture on Christmas Island for quite a few years and you are at the stage that 'off go the gloves and the niceties and it is time to start scratching and getting into it'.

Last night's meeting really was a good old fashioned 'Town Hall' meeting and it demonstrated the grass roots democracy that's possible and that's what is needed for everybody on Norfolk Island to garner what happened last night (Wednesday) and go forward.

Louci - We have had a number of those 'Town Hall' meetings.

I said it last night, and probably through the Conference. Because I'm the one that deals every day with the legislation that's supplied every day from Western Australia (WA) to Christmas Island I can tell you what you are in for and it is a legislative nightmare.

The Service Delivery Agreements (SDA) between the Commonwealth and the WA State Government - they don't work. There's a lot of issues and I face them nearly on a daily basis. The Shire President and Councillors know because I certainly let them know what the problems we have. So you are going to get apparently the NSW legislation applied to you. I think the other fundamental thing is part of my studies is you, as we don't, have a right to vote in the WA Parliament elections. So, you will have the legislation applied to you from that parliament, but you don't have a right to vote in this system. It puts those politicians in the WA or the NSW parliament that affect your daily lives and that's fundamentally a democratic deficit.

So Kelvin, can you tell us when a Western Australia law is applied to Christmas Island and can you talk us through how you get it and then how the community [gets it].

We get it from the SDA and I think there are 42 in place with various agencies in WA. To give you an example with the Town Planning Act in WA. The Minister in WA would put through an amendment to that legislation and that would apply automatically to Christmas Island but the Christmas Islanders did not vote for the WA Planning Minister or any other. So that is an example of the democratic deficit. It is not representative government when we have the legislation applied to us from a parliament that the people on Christmas Island don't vote for. We can only vote in the Federal elections.

Louci - For the people on the ground. Tomorrow they've got a new law but how do they know what that new law is. Do they look on the Internet or whatever,

Look, it happens on Christmas Island because a lot of the people in the street don't understand it. Motor Vehicle Registry is another example, the Health Act and the various instruments of legislation. The average person in the street doesn't understand that the CEO of the Shire has trouble understanding it at times. Why and how does this come about? It is an inevitably that it will come to you if this system is put in place where you will have to deal with the complexities of the NSW legislation as it is applied. Unless it is inconsistent with the Commonwealth legislation. But as it applies to you on this island that is what will happen to you.

Louci - and so the Shire Council then goes back to Western Australia and lobbies?

No. Those is no avenue for that. The only occasional avenue for discussion about how legislation applies is in the service delivery arrangement consultations. They used to be thorough; they used to be frequent; but in recent years it has been zero. Last year we had the re-institution of visits from the Department of Infrastructure and Regional Development from the Perth office at our insistence to come and talk through a programme of re-negotiating the service delivery arrangements which had all expired. Now that's the only time we get to talk about the services. But in terms of the legislation there is no information provided by anybody to the community of Christmas Island about legislation.

Many years ago, in 1992, we had the process you're going to go through with the application of the WA law. It was called the new legal regime and replaced Singapore ordinances, old Colonial legislation, a mish mash of ordinances of those laws, if you like, to replace WA laws but the Commonwealth Minister, Mr. Briggs for example, is responsible for promulgating - they are not passed through any parliament, by the way - the ordinances are presented to the parliament and if not questioned they become effective within 3 or 4 weeks. So there is the potential for members of the parliament to ask questions about an ordinance, but the ordinance is not passed as legislation. So there has been this mish mash in the past.

Now the application of the WA law as a default law of Christmas Island becomes a Commonwealth law for Christmas Island - we are not part of WA so we don't get to vote. The information about laws, the information about regulations, and our Ministers determine regulations, that's how the Westminster system works , the Parliament passes the laws, the Act becomes the guide line for the Minister to then develop regulations so that the Act of Parliament can be enforced. The business of the Act is executed through the system of regulations.

Now none of that is transmitted to Christmas Island. Initially, when the new laws were applied, the Department of Territories (as we call it), had a Legal department and they provided legal Impact Statements in 3 languages to our community - the main language is Mandarin (Chinese), Malay and English. The Department would produce legal Impact Statements about all legislation on Christmas Island. We don't get that any more. The Department has been reduced in staffing, the lawyers are no longer employed by the Department, they don't have the resources. Each government has cut the Public Service so we've got a Department and a government saying 'we want all the power to rule' but they deny themselves the capacity to rule and they are destroying what we see on Norfolk Island is a very clear, responsible, effective capacity that you have within your own community to rule yourselves and that is very, very disturbing.

NATIN 's website is gone but we can now be found on the resident's page on Norfolk Online. There you'll find Information, the Factsheet, Who can apply and the application form.

New nursery for Phillip Island

Norfolk Island National Park has recently been successful in obtaining a grant from the Foundation for National Parks and Wildlife to install a new nursery on Phillip Island.

The construction of a small nursery facility on Phillip Island will greatly enhance the rehabilitation processes by enabling the propagation of threatened and endemic flora of Phillip Island. The project will establish a new tunnel house, repair the existing shade house and allow us to construct a plant 'hardening off' area.

The nursery will be installed with timed sprinkler systems to ensure a constant supply of water when park staff are unable to gain access to Phillip Island. A remote camera system will also be fitted in each of the tunnel and shade house structures to monitor the progress of the plants and efficiency of the watering system. This will be backed up with a remote system override to switch on the sprinklers in times of need.

This new facility will enable more than 500 native plants to be established on Phillip Island each year. It will also strengthen the quarantine precautions for the island by eliminating the risk of the introduction of soil borne disease.



Phillip Island is now considered 'ark' an threatened species conservation. The island supports vegetation of remnants critically endangered and endemic species and the lack of cats and rats makes this island incredibly important. It is envisaged that Phillip Island could play a role in the long term protection of many of our iconic bird species, such as the Pacific Robin, the Slender-billed White-eye and, of course, green parrots, while the threats of cats and rats on Norfolk are being addressed. Increased vegetation cover will improve the opportunities for successful colonisation and

breeding of these birds on Phillip Island.

The on-going rehabilitation of Phillip Island is a significant and well known success story across Australia and the South Pacific. The construction of a functioning nursery will positively impact on a number of listed fauna species that inhabit the island, the threatened and endemic flora of Phillip Island, and help reduce erosion issues.



Police News

2014 Statistics

The 2014 crime statistics provided in the previous weeks very clearly show that Norfolk Island is a community that is safe and welcoming. There is however one crime statistic that goes against this trend and unfortunately does not provide a very flattering picture of one aspect of Norfolk Island: our drink driving statistics.

The below graph is of all blood alcohol content readings for the period 2009 to 2014, with the thick horizontal line representing the blood alcohol content legal limit of 0.08% for full licence holders (0% for L and P platers). We have not included figures pertaining to those also detected with a drug content, of which there are some significant readings.

Some may say that the 7 detections for 2014 do not represent an excessive number. We would suggest that this is missing the point. It must be remembered that at present, Norfolk Island legislation restricts enforcement of the drink/drug driving laws to a reactive strategy, thus the above represents those people who have first come to notice by their manner of driving, usually a collision. What is of concern is the number of extremely high readings that have been detected. Readings of such magnitude, especially if a repeat offender, would regularly attract a gaol sentence on the mainland.

We doubt that very few in this community would find the above blood alcohol content figures acceptable, especially when our families share the roads with these motorists. We know there is a large proportion of the community that don't because they've told us so. We also know there's a proportion of the community that are resistant to any change on this issue - to any tightening of the legislation to help prevent the incidence of drink/drug driving and the terrible impact it has on the community.

With the introduction of changes to legislation in the near future, it is highly likely that Random Breath Testing and Roadside Drug Testing will be introduced. It is a change that we, both as police and community members are looking forward to. Any measure that promotes safer roads for us all is to be encouraged.



Technology

Finally, I just wanted to communicate a few hints and tips on technology use and then promote the Norfolk Island Central School Facebook page which was launched this week. The Laptops that the students received earlier this term after outstanding work by Rotary and school staff, have limited capacity for storage and should not be used as mass storage devises for Music, Movies and Games. It is fine to use the devise for viewing or playing games (not during class), just not to save those items to the devise, as not only is this restricted but most importantly it slows the computer and entire network down. The best strategy for efficient use of the laptops is to save all content to external hard drives or USBs, and to have two storage devises. One for Week A and one for Week B, and rotate these each week backing up all content from one storage devise to the other at the end of each week. This not only guarantees efficient functioning of your laptops, but also means you are backing up each week and will never lose more than one weeks' worth of content at any point in time. Also, the official school Facebook page is up and running (The profile picture is the school sign) and is designed for enhanced communication with the entire community of the island. As this is an official school page it does have strict social media policies and restrictions, which are detailed in the first post on the page. Simply, all members must be responsible digital citizens and not be offensive, inappropriate or rude to other on this site. It is not for social commentary,

nor judgment, it is simply for information sharing, questions and community engagement.

- Sometimes be a child when it all becomes overwhelming sometimes, they can return to the safety of a known childhood.



Norfolk Community let down Again

Early last week I asked McKenzie from the on-Island Commonwealth contingent what I considered to be a simple question; The question was "in the Commonwealth's 136M supposedly set aside to fix Norfolk has an amount within this budget been set aside for the purchase of Barges or Ferry's?" The reason I asked was I would like this islands community to build and own a couple of Barges come Ferry's and that I fear tourists are going to get sh*#ty when they have to swim to the brand new lump of concrete the Commonwealth thinks is a pier.

The answer I received was a paragraph from the JSC report with a footnote saving 'this answers your question'. Oddly enough the JSC paragraph conflicts with what is now happening, has no mention of vessels but does mention a 'later budget' which I naively assumed was the now 136M budget. The conversation went down-hill from there with me apparently being offensive and in-appropriate when questioning "whether McKenzie gave a s*%t about this community?" I then referred the same question to a more senior off-Island Commonwealth Staff member and received the answer that; "no the Commonwealth has not included vessels within this budget and if the island was to continue to be involved in the design or acquisition of these vessels just ensure that they fit with the proposed jetty design." I thanked them for their input as this gives the Norfolk Community a significant opportunity in providing vessels.

Now the vessel issue was sorted we just needed to correct the Jetty design to better suit our vessels. In simple terms a Port or Harbour or Jetty or Weir infrastructure is designed around "potential use" which means it's designed around vessels. The entire community is in agreeance that "a straight extension to the Cascade Pier will do nothing to lift the probability of increasing cruise line patronage." The Cascade Pier Design must focus on deflection to achieve a calm water area. I have spoken in depth to Worley Parsons and their response is "for the current design to change then significant on-islander stakeholders must support that change". So off I go to Lighterage but decide to abide by protocol and request Bruce Taylor to ask Lighterage as to whether they wish to discuss the fact that a significant opportunity exists for this Island to persuade and ensure Worley Parsons incorporate a calm water precinct in their design. In this discussion I was informed by Bruce that they (I assume NIA) have already reached a consensus that the cascade project will proceed as is with a view to a port at some later date. I was a bit lost for words at this as the number of businesses closing and the number of people struggling because of the Commonwealths lack of action is significant. I maintained I still wished to speak to Lighterage. Mid this week Bruce informed me that Lighterage did not have an interest in speaking to me. I than rang several Lighterage personnel who informed me they had not been contacted or they were not informed as to the subject of any meeting. Make your own assessment of this as I have made mine.

Norfolk United; This community must have a voice. With a voice it can change almost anything. An example of how poorly this community is represented is the above incredulous crap. This community needs to put an end to this stupidity and submit a motion for the Investigation of NIA members actions. I would further this motion by bringing into question the credibility of having a senior employee in a position of influence within this communities administration network who is also in a private relationship with the now un-elected chair of an advisory council. You have to be joking. As in-competent as the Commonwealth sometimes appears to be, even they would never allow this potential for conflict to happen.

Normally this situation would force either party to step down from their appointment but I guess Hardgrave probably forgot to let Briggs know of the potential conflict. No surprise there! If I remember correctly the key to ensuring this type of situation never happens is honesty through democracy.

This community has been at the mercy of a minority for too long. This must stop. A united Norfolk, where everyone has a say, is building momentum now. Ensure you have your say and be part of the single greatest initiative that this beautiful little Island has seen to date. Support "Norfolk United" by responding to a mail out which you will receive by Saturday of next week.

In absolute disgust but now with a more hardened resolve.

Warm Up - Cool Down

With the cooler weather upon us, it is especially important to incorporate warm-up and cool-down activities into our sport. Warming up helps prevent muscle injury as it prepares the body for activity. It aims to increase the body's core temperature, increase heart rate and increase respiration rate. Cooling down helps clear the body of lactic acid, meaning less soreness and stiffness the next day!

The ideal warm-up incorporates the muscle groups and activities being utilised in training or competition. Begin with low-level intensity and gradually increase to the level required when competing. 5 to 10 mins is usually enough, although it may need to be longer in cold weather.

Cooling down is just as important, especially after vigorous exercise as it aids recovery. The cool down should occur immediately after training activities and should last 5 to 10 mins. Cool down exercises are similar to those used for warming up but with lower intensity, such as jogging or walking rather than running.



- Have you received a Healthcare invoice but are shortly to depart Norfolk Island?
- Have you received a Healthcare invoice but wish to apply for suspension of the Healthcare Levy and the Medical Evacuation Levy on the basis of having satisfactory alternative healthcare and medical evacuation cover?

He said the last time the circus was in town six years ago, many of the shows sold out and extras were put on to cope with demand.



WW1 - First Island Female Recruit

13 to 19 June 1915

13 June 1915 at Anzac trench warfare was aided by the trench mortar which had been utilised on the Western Front and was becoming gradually more available to the troops at Gallipoli. The trench mortar was to prove particularly useful at the four strong points held by the Turks at Quinn's Post, German Officers Trench, Johnson's Folly and Lone Pine. All four sections of the Turkish front line were perfect targets for the mortar bombs as were the allied defences opposite. The first issue of fresh bread on Anzac from the 1st Australian Field Bakery on Imbros which, despite getting wet on the trip, was considered better than the standard issue of hard army biscuit known as the 'Anzac Wafer'. The Western Front had entered a period referred to as "static warfare" which was to extend for the next three months.

Stephen Cornelius (Lerm) Christian on 14 June embarked on transport A62 "Wandilla" from Sydney with the 6th Reinforcements, 13th Australian Infantry Battalion. The Embarkation Roll for the "Wandilla" records number 2125 Christian Stephen, Private, 21 years of age, farmer, single of Steele's Point Norfolk Island, next of kin given as mother Mrs M Christian Steele's Point Norfolk Island, religion as C of E and he enlisted on 26 May 1915

On 15 June E Lester Quintal (1st Auckland Infantry) was transferred from Anzac by Minesweeper to the 2nd Australian Stationary Hospital at Mudros. Quintal was yet another victim of the dreadful and particularly the unhygienic conditions at Gallipoli, diagnosed as suffering with Dysentery and Influenza. George E Evans was recorded as still being at Liverpool, NSW. On the Western Front the British and Canadians attack in the French section of the Front Line at Givenchy - les - La Bassee (the second action of Givenchy) in support of the second Battle of Artois, a combined battle with the French. Following a 48 hour bombardment supported by air observation, to attempt to achieve a more efficient use of artillery and after explosion of a 3,000 pound mine which left a hole some 50 metres across but little else, the troops advanced at 5.58pm against formidable defences. The attack failed with considerable losses.

16 June saw the first Norfolk Island female recruit Evelyn Jane (Eva) Nobbs, sister of G R F Nobbs then at Gallipoli, who enlisted in Sydney as a Nurse in the Australian Army Nursing Service. Eva was described as height 5 feet 4 inches (1.6m), weight 119 lbs (54.1 kgs), chest 34 inches (0.85m), complexion fair, eyes grey and hair brown. Gave her religion as C of E, occupation as Nurse and she stated she was not married. Gave her Next of Kin as mother at Ferny Lane, Norfolk Island and signed enlistment papers Evelyn J Nobbs. Nurse Nobbs embarked from Australia on the day of her enlistment on A63 "Karoola" from Sydney with the 1st Australian General Hospital. The Embarkation Roll for the "Karoola" stated she was 25 years old, nurse, single, home address Strathfield NSW, next of kin given as her mother Mrs E Nobbs Ferny Road Norfolk Island, religion as C of E and she

enlisted on this day. The action on the Western Front near La Bassee ceased having proven to be a complete disaster for the British and Canadian troops involved. Turk mining operations approaching Quinn's were discovered by Australian miners who put an end to the activity by blowing up the offending tunnel. On the western front a second offensive in the Second Action of Givenchy saw an attack after a 2 hour barrage attack by British and Canadian troops. The Germans were waiting and the attackers "failed to gain a permanent hold on the opposing front line". Further to the north the Battle involving an attack by the British on the German defences on Bellwaarde Ridge to the East of Ypres in the Ypres Salient commenced. The usual bombardment commenced at 2.50am followed by the British troops attacking in a twelve hour encounter. The battle fought on a field only 0.5 miles square saw the British losses amounting to 4,000 men.

Richard (Darkie) Douran on 17 June joined 4th Australian Infantry Battalion at Gallipoli. The Battalion was at McLaurin's Hill (south of Steel's Post) where 4 Battalion Daily Orders stated a thorough practical test in their knowledge of musketry was required of all reinforcements (it was added "despite what they say they have done"). On the Western Front the French made a successful attack North of Arras whilst the Germans evacuated and set fire to Metzeral in Alsace.

18 June at Anzac the Auckland Mounted were relieved by 9th Australian Light Horse and proceeded to bivouac at beach end of Reserve Gulley. On the Eastern Front the victorious German armies were approaching the gates of Lemberg and to date the Russian losses were estimated at 400,000 dead and wounded, and 300,000 prisoners, besides 100,000 lost in Poland. On the Western Front the second Battle of Artois ended with the French losses during the battle of 102,000 men.

19 June saw the 6 Australian Light Horse at Anzac moved from the front line to Deadmans Gulley "for a spell" without Sarnum Quintal who was severely injured a week earlier. The Regiments strength was 16 Officers and 403 other ranks. News on other island recruits included W F Young (Reinforcement Auckland Mounted Rifles) who was admitted to hospital in Egypt and Warrant Officer G H Stanley Rawdon, grandson of George Hunn Nobbs, who was born in England but enlisted in Sydney in the AIF on 17 September 1914, departed Australia on 22nd December and was discharged overseas from AIF's 8th Australian Army Service Corps having obtained a commission in the British Army 8th ASC. Stanley, who was 32 years and 2 months at the time, was gazetted as a temporary 2nd Lieutenant Army Service Corps in the London Gazette of 8 July, with appointment effective from 20 June 1915. A letter dated 1921 refers to Stanley as Captain, Royal Artillery. G E Evans, brother of John A Evans, then at Gallipoli, embarked at Sydney on A6 "Kanowna" as George Evans Hill in the reinforcements to 20 Australian Infantry Battalion. The "Kanowna" Embarkation Roll stated he was number 1713, George Ewens (sounds very Norfolk) Hill, Private, 19 years of age, farm hand, single, home address Norfolk Island, next of kin Mrs George Nobbs Norfolk Island, religion C of E, enlisted 27 May 1915.

Page from the Past

Saturday, 16th June 1973

Vale - Daniel Francis Stanton, one of Norfolk's younger married men, was drowned in a tragic accident of Kingston Pier last Wednesday evening.

Danny was the husband of Muriel (ne Dehnt of Te Puke, New Zealand) and only son of residents Gwen and Tom Stanton. He spent the major portion of his school days on Norfolk Island, leaving to go to work in New Zealand. He had been back on Norfolk for quite a few years and married Muriel only a matter of some two years ago. He went into business on his own as a spray painter about 6 weeks ago.

To Gwen and Tom, to Danny's sisters Kathy and Elizabeth and their husbands, and to all the many relatives and friends of the Stanton and Dehnt families, our deep and sincere condolences.

ON BEHALF of the Administrator and all those whose duties involved them in the activity which followed the fatal accident at Kingston Pier on Wednesday, I thank the many people who generously assisted with equipment, skills and determined personal effort.

IT HAS BEEN a tragic week for the island, coming right on top of the enjoyment and celebration of Anniversary Day.

The news of the fire that gutted the fairly new home of Roy and Monica Smith in Mission Road last Sunday evening was a great shock to us all.

According to Roy, he and Monica and young Michelle had gone to bed early that night. Monica awoke to a smell of burning and they were all lucky to get out of the house just as the roof caved in.

Roy sustained burns to his arms and a slight one on his forehead. Monica grabbed Michelle out of bed and they were lucky to escape without injury.

They lost everything. Apart from household effects, the large collection of Norfolk Island films that Roy has amassed over the years with his roving camera and the historical ones he has obtained from many sources were also lost.

THANK YOU - Roy, Monica and Michelle would like to thank all those kind people who came and helped them when their home was destroyed by fire with everything they possessed. Their grateful thanks for the clothing, food, fridge, cutlery, crockery, etc. They cannot list the names of all who have helped them. All they can say is "God bless you all - and thanks." Roy, Monica and Michelle.

Concern at Delay - At the last meeting of the Norfolk Island Council, concern was expressed at the delay in the work on the proposed new Travelodge at Kingston.

In opening the debate on the subject, Cnr. Randall made mention of the resolution of Council after its special meeting on 23rd May. "The Norfolk Island Council", he said, "is most concerned that the National Trust, a group who are uninformed on local affairs, is being allowed to illogically interfere in the peace, order and good government of Norfolk Island, especially as the avowed policy of the Labor Government is to

respect the wishes of the elected representatives of the Norfolk Island people.

"By its past performance, the Norfolk Island Council has always shown its respect and support for the restoration of the historical aspects of Norfolk Island and has a firm policy restricting the growth of tourist accommodation to protect the unique character of the island" he said. "In accordance with this policy, we approved the Travelodge project to ensure the tourist industry would be brought to the high standard adopted by Travelodge. It is a matter of fact that the Kingston area is the focal point of tourist activity of all types and that for the economic situation to remain in balance it is necessary to blend the old with the new in preserving the historical assets."

Cnr. Quintal then asked the question as to who, in actual fact, owned these historical buildings. He was of the opinion that the historical buildings on Norfolk Island were held in trust by the Commonwealth Government on behalf of Her Majesty The Queen and the community of Norfolk Island and not the Australian Government. "These are our national buildings, not Australia's" Cnr. Quintal said.

The Administrator said that his understanding was that all assets on Norfolk Island are Crown assets. "There is no Crown in the right of Norfolk Island but there is a Crown in the right of the Commonwealth" he said. He went on to say that this raised matters about which he will have discussions when he went to Canberra. The Administrator also remarked on the question of insurance, querying "why should Norfolk Island be responsible for insurance of buildings that are assets of the Crown."

Did You Hear? - There is a hint in both English and Australian papers that Princess Anne and her fiancé Mark Phillips may honeymoon on board the "Britannia"? cruising around the South Pacific it has even been suggested they will arrive in time for the Commonwealth Games in Christchurch and will be joined there by the Queen and Prince Philip.

Letter to the Editor - At the last Council meeting held on 5th June, 1973, the Administrator belatedly referred to a Treasury advance presumably obtained for the purpose of financing the electricity undertaking. So far as the public are concerned it has no knowledge of any borrowing done with the approval of the Council and in view of the doubtful state of the Island's finances it would be of great interest to know- (a) The total amount borrowed from the Treasury or any other source;

- (b) How any such loan or loans are repayable;
- (c) The amount of interest payable, if any;
- (d) The date any loan or loans are repayable.

It does seem unreasonable that the Island can be committed to any form of borrowing without the knowledge and approval of the people who live here. I sincerely hope that the information requested can be made public at an early date. Yours etc. D.Lusk.


