TRAFFIC ACT 2010 (NI)

TEMPORARY CLOSURE OF CASCADE ROAD

I, **Andrew Roach**, General Manager of the Norfolk Island Regional Council, under section 50 of the *Traffic Act 2010* (NI), close that part, or parts, of the road specified in Part 1 of the Schedule to all vehicular traffic (except any vehicle specified in Part 2 of the Schedule) for the period **7 December to 10 December, between the hours of 7am and 5pm on each day** as I am of the opinion it is necessary for public safety and to enable the safe transportation of loaded Containers from the Barge/Jetty to the required locations at Burntpine town centre.

SCHEDULE

Part 1 – Part of Cascade Road as shown in the below picture, the section from Harpers Road Intersection of Cascade Road – to the Cascade Pier proper. The road closure to be officially signposted by Council staff, or as directed by Council staff during the road closure period.

Part 2 - Exempted classes of vehicles:

- Vehicles and plant authorised by the General Manager of the Norfolk Island Regional Council or delegate for the delivery of goods or services
- Council vehicles and plant involved on official business
- Police, ambulance, fire services and emergency vehicles on official business
- Vehicles authorised by OIC Police or delegate thereof
- Vehicles required by Burnt Pine Fuel for the discharge of fuel

TEMPORARY CLOSURE OF TAYLORS ROAD – FRIDAY 23 DECEMBER 2022

COMMUNITY REUSE CENTRE – NIRC WASTE MANAGEMENT

EXPRESSION OF INTEREST – 16/22

Norfolk Island Regional Council (NIRC) is seeking expressions of interest from organisations wishing to be involved in the development of a Community Reuse Centre, to support Norfolk Island's waste management goals.

In 2022, the NIRC Strategic Waste Management Review identified the need for a community reuse centre or recycle shop, to divert waste from export and landfilling. The Community Reuse Centre aims to salvage and return useable products for community use. This would include building products, repairable electronics and furniture, sporting equipment, glass- and kitchenware and whitegoods, as well as other useful items. The centre is expected to provide value to the community, raise the awareness around waste management and enhance the island circular economy.

Funding has been provided to NIRC by the Commonwealth Government to develop the Community Reuse Centre, scheduled for development in 2023. It will be located in the precinct around the existing NIRC Waste Management Centre and will be developed to suit community needs, including the potential to develop learning spaces for the community and other activities, where planning controls allow.

NIRC would like to hear from organisations wishing to be involved in the development of the centre, in particular parties that may have an interest in running the centre on behalf of NIRC. Preference will be given to community-based organisations or parties that can demonstrate a commitment to community outcomes.

We request the following as a minimum in responding to the EOI:

- Background of your organisation, including experience working on similar projects, either as an organisation or individual experience
- Interest in development/operation of the Community Reuse Centre
- Preliminary ideas on the scope of the Community Reuse Centre
